In their place, perhaps a question on pre and post awareness/ understanding of Islam / Muslim culture? I would think that police officers' understanding and knowledge would increase after spending time with the Somali youth. It has been a bi-product in the past dialogues, wouldn't you agree Paul? This would show a demonstrable impact in a positive way and avoid the negative language that is a concern to all of us.

Hi Everyone

After reviewing the survey in its entirety, I have made the decision to withdraw from any ongoing and future involvement with CVE initiatives in Boston. I first became involved with this project at a time when I had full faith in the direction that the team was headed, and the leadership of the administration guiding this important work. In recent weeks I have grown increasingly uncomfortable with the intentions of the program. I look

forward to continuing to partner with our local law enforcement and community leaders to find ways to combat violence in our neighborhoods and across the country, but I cannot in good conscience continue to support any local partnerships with CVE initiatives under the Trump administration. I'd like to remind those still involved with the program that extremism, radicalization, and violence exists across cultures, religions, and ethnicities - focusing efforts specifically on one subgroup will ultimately create deeper divisions in our fractured society, doing more harm than good.

Said, some of USY students, the USY intern, and myself reviewed the youth and police initiative survey. I was not able to review the police survey during this time because I was in the midst of moving all of my items to New York and packing for Kyrgyzstan.

Thank you again for taking on this project. I know that the USY team is excited to partner with you all.

Here are our thoughts:

Framework: I think by identifying the appropriate outcomes and outputs, it will be useful in better organizing the surveys because then we know what we are trying to measure. Without this information, it was a bit difficult to identify what the survey was trying to measure and so our comments are based on what we thought might be useful to consider.

I would suggest while thinking about the outcomes and outputs, think in terms of protective and risk factors (risk factors could be their environment – neighborhood, school, home life – lack of social integration due to potential ultural differences at home and then in community, economic resources, etc. AND protective factors which could include strong family structures, high parental employment and education, mentors – which also facilitate successful integration – if you think about the project with police officers, you could frame it as how building trusting relationships and understanding between police and Somalian youth can assist in mentorship building opportunities (which could increase protective factors) – I think it would be very beneficial to review the literature that is available online around refugee integration – this could help inform the thinking. Also be aware of the cross work that USY does with your program, it might be difficult to measure changes in behavior or knowledge if you do not isolate the work that USY does already. Here are more suggestions on specific questions:

- 1. Explain your abbreviations (what is SRO?)
- 2. Witnessed a "violent event" is too broad, a fight in school can be considered a violent event, or seeing fights on the streets specify this (at home, in the community, neighborhood, school, etc?). Also highlight or bold in capital, in the PAST THREE MONTHS, because students may be refugees and could have been around many violent incidents in their life. Maybe have a follow up question, what was the violent event?
- 3. Define "interaction" was it positive, negative?
- 4. "contact with criminal justice system" be aware that contact could be something like going to court for a speeding ticket or even going to court if their parents are getting divorced.
- 5. "Considered joining a gang" could be rephrased as "Have you been approached or pressures to join a gang on the street or in your community?"
- 6. Spent time with someone your know owns a gun or in a gang (maybe these students are classmates of people in gangs or maybe they know someone that owns a gun for protection) what would this attempt to measure
- 7. Rephrase "Spent time with someone that gets into trouble at school or with police" to "Are you friends with someone ... " maybe they go to school with someone that always get into trouble, what would this try to measure?
- 8. Many of the questions on the second page at the bottom were very repetitive, shorten it up.
- 9. Get rid of the internet questions, what would this try to measure? Why would it be important?
- 10. Shorten the survey to 1 or 2 pages if possible.
